ATTENDED FUNERAL (funeral director's charges only)	£1,990
This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.	
Taking care of all necessary legal and administrative arrangements	£994
Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into the funeral director's care.	£295
Care of the deceased person before the funeral in appropriate facilities. The deceased person will be kept at [both] the funeral director's [branch premises] [and at other] [non-branch premises]	£125
Providing a suitable coffin – this will be made from Light Oak Effect Foil	£225
Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer)	£1
At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle	£350
UNATTENDED FUNERAL	
This is a funeral where family and friends may choose to have a ceremony, event or service for the operson, but they do not attend the burial or cremation itself.	deceased
Burial (funeral director's charges only)	£1,130
Cremation (funeral director's charges plus the cremation fee) ²	£1,550
FEES YOU MUST PAY	
For an Attended or Unattended burial funeral, the burial fee ¹ .	£200 - £600
n this local area, the typical cost of the burial fee for local residents is:	£200
For a new grave, you will also need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee. In addition, the cemetery may charge a number of other fees.	
For an Attended cremation funeral, the cremation fee ² .	£730 - £1,045

ADDITIONAL FUNERAL DIRECTOR PRODUCTS AND SERVICES

This funeral director may be able to supply a range of optional, additional products and services, or to arrange (on your behalf) for a third party to supply them. Examples include:

Additional mileage (price per mile)	 65 _P
Additional transfers of the deceased person's body (e.g. to their home, to a place of worship etc.) (price per transfer)	£250

The funeral director can give you a full list of what they can supply. They are likely to charge for these additional products and services, so you may choose to take care of some arrangements without their involvement, or you can use a different supplier.

¹This fee (which is sometimes called the interment fee) is the charge made for digging and closing a new grave, or for reopening and closing an existing grave.

²In England. Wales and Northern Ireland, you will usually need to pay doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation
