## Notes

Charges for Non-Residents are double those of residents (except in cases of Council Tax payers who have become Non-Residents due to ill health or infirmity) This is only applicable to those who have been non residents within 5 years. This charge applies to the fees for the purchase of the grave space and also the interment.

When two sets of ashes are being interred at the same time then the charge will be 1.5 times the standard rate.

There will be a surcharge of 30% applied to any interment, where the actual coffin size is smaller than that submitted, resulting in unnecessary and excessive soil being excavated and handled.
